I am directed to refer to the subject noted above and to state while hearing the plaint Suit No. 488 of 2021 filed by M/s. Mediflow Pharma against Province of Sindh & Others, the Honourable High Court of Sindh has been pleased to pass the following orders:

.....“Till the next date of hearing, defendants are restrained from awarding any contract for the Drugs / Medicines as described in Para No. 07 of the plaint, namely (Group “D” General Medicine IV Fluids) for the year 2020-21.”

All pointed items in para No. 07 i.e. MIV0012, 0013, 0014, 0016, 0017, 0018, 0019, 0023, 0034, 0035, 0039 & 0041 are already stopped due to decision of CRC, except item No. MIV0045, which is also need to be stopped due to such restrain orders of Honourable High Court of Sindh.

You are therefore, requested to please stop the procurement of below mentioned item till the decision of Honourable High Court of Sindh. It is also requested to stop/rectify supply orders if issued, accordingly.
