In reference to a decision taken during evening Meeting for COVID-19 under the chair of Honorable Chief Minister Sindh Dated: 07-03-2020 regarding subject cited above, all hospitals of the province must establish a front line desk for COVID-19, forthwith, under intimation to your Office. Moreover, one advisory must be displayed in front of every hospital as given below:

“PERSON HAVING TRAVEL HISTORY ANYWHERE ABROAD DURING LAST 14 DAYS MUST CONTACT & REGISTER HIMSELF/HERSELF AT COVID-19 DESK ESTABLISHED WITHIN THE HOSPITAL.”
