
SUBJECT: OFFER OF APPOINTMENT TO THE POST OF "DAI " BPS-01" AGAINST DECEASED QUOTA.

With the approval of the Higher Authority i.e Chief Secretary Sindh, as well as to the Secretary Government of Sindh Health Department Karachi and recommended by DRC under the Chairmanship of Deputy Commissioner District Sanghar on 16-07-2021 , you are hereby offered a post of **Dai BPS-01** posted at the disposal of District Health Officer Sanghar against (Deceased Quota) on the following terms and conditions.

- He / She will be on probation period for two (02) years during which period his services are liable to terminated without any reason being assigned but after confirmation he/she will be governed by the relevant services rules.



- In case he / she wishes to resign at any time he /she has to serve one month's notice else one month's pay will be forfeited to Government.
- His / her appointment is subject to production of original testimonial certificates as well as fitness certificate from the Medical Superintendent / Civil Surgeon concerned and verification of character antecedent by the Police.
- He / She will not be entitled to any travelling allowance for presenting himself / herself before the Medical Superintendent / Civil Surgeon for Medical Examination or joining his /her first appointment.
- He / She is liable to served anywhere in Province of Sindh.
- He / She should appear before the Medical Superintendent / Civil Surgeon, Services Hospital concerned for Medical Examination and obtaining the Fitness Certificate within 15 days of being declared fit failing which order will stand cancelled automatically.
- After he / She is confirmed he will be governed by such rules and orders relating to scale of pay / ordinary leave / earned leave / travelling allowance / pension / Scheme and disciplinary rules or other which may be issued by Government from time to time for the category of Government Servant to which he belong.
- If he / she accept the post on above condition he should report for duty to the undersigned for further posting / appointment.
