SUBJECT: **SHOW CAUSE NOTICE**

The allegation of your alleged misconduct is as under:

“The District Health Officer, Kamber-Shahdadkot@Kamber has reported vide his letter dated 10.09.2022 that you were found absent from duty on 10.09.2022 at 11:00 a.m”. This Act tantamounts to misconduct on your part as defined in E&D Rules 1973.

2. Therefore, in exercise of the power conferred under Rule-4 (a) read with sub-rule (3) of Rule (5) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, I, SECRETARY, HEALTH, GOVT OF SINDH as an Authorized Officer:

- a) am of the opinion that in view of the allegations of misconduct as per detail given above, there are sufficient grounds that disciplinary action be taken against you under the said Rules and;
- b) Have decided that it is not necessary to have an enquiry conducted through an Inquiry Officer or an Inquiry Committee.

3. I, therefore, inform you through this notice that on the grounds given above, it is proposed to impose upon you any one of the major / minor penalty as described in Rule-4 of the said Rules. You are accordingly called upon to Show Cause as to why proposed action should not be taken against you.

4. In view of above position, you are directed to submit your reply, which should reach to the undersigned with in Fourteen (14) days from the date of receipt of this notice failing which ex-parte decision will be taken under the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973. You may also indicate whether you would like to be heard in person or not.
