Terms & Conditions of hiring of above named Doctors are as under:

- 1) That they above named candidates are required to submit the photocopies of their relevant academic / professional qualification certificates, Domicile, PRC, CNIC and (04) latest passport size photographs to the concerned District Health Officer (DHO).
- 2) That their hiring is purely on "**Service Rendered Basis**" for the period of eighty-nine (89) days extendable on satisfactory performance.
 - 3) That they will go through required training before any assignment.
- 4) That their hiring shall be health facility base decided by the DHO concerned on need basis
 - 5) That their hiring is non-transferrable and transfer request shall disqualify the candidate for further retention in department.
- 6) That they will be paid salary from the Head of Account "**A039-General-A03919-Payment to other Service Rendered to Medical Officers**".
- 7) That their hiring will not entitle for the confirmation in Government Service.
- 8) That they will not be entitled to any traveling allowance for joining or training.
- 9) That they will be liable to serve anywhere in the province of Sindh in case of any emergency.
- 10) That Health Department, Government of Sindh has right to withdraw / cancel the hiring on any candidate at any time / stage without serving any notice reason.
