

## GOVERNMENT OF SINDH HEALTH DEPARTMENT

## **NOTIFICATION**

No.SO(PM-I)Hiring.of.S.N/2020-20: In pursuance of Section 3(1) of the Sindh Epidemic Disease, Act, 2014 and in wake of the emergency declared in the Province of Sindh for Corona Virus (COVID-19), the Government of Sindh has established ICUs / HDUs and Isolation / Quarantine Centers throughout the province. In order to meet the shortage of required Staff Nurse. in Health facilities, the department, with the approval of Competent Authority i.e Chief Minister Sindh, Staff Nurses (who have passed the written test of Sindh Public Service Commission (SPSC), and waiting for their interviews, were considered for hiring: out of (2349), who passed the written pass of SPSC, (1227) Staff Nurses have joined and subsequently their services were hired for (89) days (extendable subject to their satisfactory performance) under "Service rendered charge basis". The contract of (1227) Staff Nurses were later on extended for (89) days more after receiving of their attendance, regularity & punctuality certificates from concerned authorities. However, the services of 909 Staff Nurses were extended for 02<sup>nd</sup> time after receiving the attendance, regularity and punctuality certificates from concerned authorities as per letter No.DNSK/F.III( ) 7834/39 dated 25.09.2020 received from Directorate of Nursing Sindh. Karachi. In view of satisfactory performance, the services of (466) Staff Nurses (who could not qualify the SPSC exams) are hired for another period of (89) days, on the same terms and conditions when hired initially, with effect from 28.12.2020.
