SUMMARY FOR CHIEF MINISTER SINDH

SUBJECT: POST-FACTO APPROVAL TO ALLOW DR. SYED NADEEM HASSAN RIZVI, TO CONTINUE AS PROFESSOR ON PROBONO/HONORARY BASIS IN NATIONAL INSTITUTE OF CARDIOVASCULAR DISEASES (NICVD) KARACHI

The Minister Health & Population Welfare Department, Government of Sindh / Chairperson of Executive Committee, NICVD Karachi has directed to issue the notification to allow Dr. Syed Nadeem Hassan Rizvi, to continue as Professor on probono / honorary basis in National Institute of Cardiovascular Diseases (NICVD), Karachi.

2. Dr. Syed Nadeem Hassan Rizvi, Professor of Interventional Cardiology NICVD, Karachi has been retired from Government Service on attaining the age of superannuation March, 2021. In his application, Dr. Syed Nadeem Hassan Rizvi has requested to allow him to serve as Honorary Professor of Interventional Cardiology on probono basis at NICVD after his retirement. He has further stated that he remained supervisor in General Cardiology since 2007 and has trained around 46 Fellows in General Cardiology since 2015 and 40 Fellows in Interventional Cardiology. At present, more than 15 Interventional Fellows who are registered with the CPSP are under his supervision at NICVD (**Annexure-I**).

3. Accordingly, in compliance to the direction of Minister Health & Population Welfare Department, GoS / Chairman Executive Committee, NICVD, Karachi, the Notification to allow Dr. Syed Nadeem Hassan Rizvi, to continue as Professor on probono / honorary basis in NICVD, Karachi has been issued by this department dated 10.05.2022 (**Annexure-II**).

4. In this regards, it is very relevant to state that the NICVD, Karachi, is an Autonomous Body is being administered through its Board of Governors, constituted under the National Institute of Cardiovascular Diseases (Sindh Administration) Act, 2014. The Governing Body is empowered under Clause 18 of the said Act for 'Appointments of Officers', which has been reproduced as under (**Annexure-III**):

"The Governing Body may appoint, subject to such general or special orders as Government may give from time to time, such officers in Grade 18 and above, and engage such consultants or experts, as it may consider necessary for the efficient performance of the functions of the Institute, on such terms and conditions as it may deem fit"
