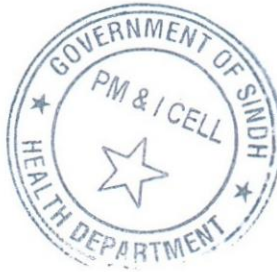

6. Instruction to bidders and list of items are enclosed.

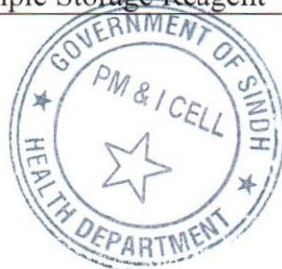
